Please read each section carefully. You will be required to acknowledge that you have read and understood various risk factors and safety measures part of the Government of Canada's requirements upon arrival in Canada.






To complete this form, you need to have the following documents:

- 5. A current student photo (Size: 640pixels X 640pixels is maximum) for ILAC Vaccine Passport

#2 Proof of your vaccination and #5 A current student photo are used for our Vaccine Passport.






ILAC and ILAC International College, Student Vaccine Passport support staff will issue our student's passport by Monday, your student's starting date.







Things that student signed on ILAC Students Consent Form/Waiver form

I hereby confirm that I have read and understood the quarantine requirements and procedures upon arrival in Canada. I confirm that I will follow all guidelines provided in this document, as well as all requirements provided by the government of Canada. I am aware that I must comply with the regulations in the Government of Canada's Quarantine Act, including the penalties of violation these requirements, which include up to 6 months in prison and/or \$750,000 in fines.

Stay-Safe Packing Essentials: Absolute Must-Have Items: Thermometer, Masks, gloves, cleaning supplies and hand-sanitizer, Toothbrush and toothpaste, a large plastic bag for dirty clothes & laundry.

Transportation from Airport to ILAC Accommodation: (If you are not fully vaccinated) It will be mandatory that the students take ILAC transfer services to follow the protocols to pick-up the student from the airport to the ILAC Accommodation and be ready to have their temperatures checked or asked.

Monitor your health: Monitor your physical and mental well-being. If you not feeling well, use the Government of Canada's COVID-19 self-assessment tool to help determine if you need further assessment or testing:

Fever (temperature above 37.8C) & other symptoms: Students must notify ILAC and HS Family immediately in case of fever & other symptoms and follow guidelines of Public Health.

Clothes worn from the airport & Laundry: Clothes worn from the airport will be put away in a plastic bag aside and not be worn until washed after 14 days of the quarantine term. Students' clothes must be washed after quarantine only. E.g. If you like to wash your clothes before, talk to your host family as it is advised to wear gloves and mask when handling the clothes and disposable bag and wash hands with soap and water immediately after or if you are in a hotel, coordinate with reception.

Face Masks: Wear a face masks at all times when leaving the room in the HS. E.g. wear a mask from your room to go to the bathroom.

Washroom: Maintain physical distancing and sanitize all surfaces touched before and after using the washroom. E.g. countertops, faucets, light switch, toilet handle, etc.

Hand Contact Surfaces with a concentration of germs: Doorknobs, light switches, house keys, TV remotes, electronic devices (like your phone), and faucet handles must be sanitized whenever touched.

Hand Washing etiquette: 20 second-hand washing must be a common practice when coming in and out specially.

Limit the use of Common areas in the household: Keeping at a minimum, when you go to other areas in the house (backyard, kitchen, living room, etc.) avoid touching any high contact surface (doorknob, light switch, etc.).

Smokers: Notify ILAC in advance if you are a smoker. You CANNOT smoke inside the room under any circumstance.



Avoid leaving your room & contact with other people: We know your room will be where you will be spending most of the time, bring something you like to pass the time. E.g. a book, download before you come movies and music in your laptop, cellphone, hard drive, headphones or earplugs & don't forget chargers, etc.

Keep your room tidy and well- ventilated: Remember your host family will not be entering your room at least for the self-isolation period. Keep your room as clean as possible - no dirty dishes inside, no leftover food, etc. Keep your room well-ventilated and clean - open your window to let the air circulate.

Fever and Symptoms at any point of your stay in the Host Family: Notify ILAC and your host family and immediately call a health care professional or public health authority to discuss your symptoms and travel history, and follow their instructions carefully. You can also use the online self-assessment tool to determine if you need further assessment or testing for COVID-19.

Chronic medical conditions disclosure: I shall disclose with ILAC any chronic medical conditions (e.g. diabetes, lung problems, asthma and immune deficiency). If requested by ILAC I shall provide a medical note stating permission to travel to Canada.

After 14 days of the quarantine period: (If you are not fully vaccinated) For the duration of your stay in Canada, please be mindful of and respect public health directives. E.g. physical distancing, hand washing, etc.

Failing to comply any of the above guidelines: Failure to comply any of the above guidelines may generate penalties to be paid to the host family and disqualify continuing the ILAC Accommodation Program and attend ILAC, ILAC International College, Georgian College at ILAC in-person classes.

ILAC COVID-19 Updates

ILAC Education Group Vaccination Policy

Fully vaccinated students will receive a green ILAC Vaccine Passport and will be able to participate in all on-campus classes and activities. Partially vaccinated students will receive a yellow ILAC Vaccine Passport. Students can immediately study on campus for up 28 days until they receive a second dose of a Health Canada-approved vaccine or a first dose of Health Canada-approved vaccine. Partially vaccinated students will be subject to rapid antigen testing once per week.
